# SUPPORT FOR THE TRIBAL COURT BY REPEALING THE TRIBAL MEMBER ACCESS TO JUSTICE ACT OF 2018

At a duly called Special Session I of the Kiowa Tribe Legislature, held this 27th day of July 2022, the following Resolution and Law were adopted.

WHEREAS; The Legislature is vested with the authority to pass laws and resolutions pursuant

to Article VI, Section 6(a) of the Constitution of the Kiowa Tribe; and,

WHEREAS; The Kiowa Constitution, Article VI, Section 6(a) Laws and resolutions which have

been enacted shall remain valid until amended or repealed; and,

WHEREAS; The Legislature enacted the Tribal Member Access to Justice Act of 2018 on a

temporary basis; however, more than five years has passed since the voters

approved the new Constitution and Tribal Court system; and,

WHEREAS; The Legislature wishes to repeal the Tribal Member Access to Justice Act of 2018.

**NOW THEREFORE BE IT RESOLVED**; that the Legislature hereby repeals Resolution KL-CY-2018-022, the Tribal Member Access to Justice Act of 2018, effective immediately.
