KIOWA TRIBE **Resolution No. KL-CY-2022-XXX**

A RESOLUTION TO FORM A KIOWA CULTURAL EXCHANGE EXHIBITION COMMITTEE

At a duly called session of the Legislature of the Kiowa Tribe held this ____ day of _____, 2022, the following resolution and law were adopted.

WHEREAS, The Kiowa Tribe is a sovereign nation since time immemorial and is federally recognized as a Tribal Government by the United States; and,

WHEREAS, The Kiowa Tribe Legislature is vested with authority to pass laws and resolutions pursuant to Article VI, Section 6(a) of the Constitution of the Kiowa Tribe; and,

WHEREAS, The Kiowa Tribe Constitution, Article VI, Section 6(i) The Legislature shall have the power to establish Executive Boards by law. Any Board established by the Legislature shall be located in the Executive Branch of government, shall be subject to the powers of the Executive Branch, and shall carry out and execute the duties called for in the laws. All Boards shall be subject to the laws of the Tribe. No member of the Legislature may also be a member of any Board established by the Legislature. Members of all Boards shall be nominated by the Chairman, subject to confirmation of the Legislature; and,

WHEREAS, The Legislature has identified a need to form a Kiowa Cultural Exchange Exhibition Committee, to form a group to travel nationally and internationally to share our tribal singing, dancing, and oral presentations; and,

WHEREAS, Kiowa Tribe Executive Branch will fund 50% of the cost in an Annual Budget or Modification, voted and approved by the eligible voters of the Kiowa Tribe. The Kiowa Cultural Exchange Exhibition Committee will seek additional funding as needed through fundraising, to cover and/or defray cost of travel; and,

NOW THEREFORE BE IT RESOLVED, that the Legislature hereby enacts the attached law entitled, “Kiowa Cultural Exchange Exhibition Committee”.

Section 1.1 Short Title

This enactment shall be known as the “Kiowa Cultural Exchange Exhibition Committee”.

Section 1.2 Purpose

The purpose of this committee is to establish a group to travel nationally and internationally and share our Kiowa Tribe singing, dancing, and oral presentation.

Section 1.3 Findings

(a) The Kiowa Tribe Legislature established a “Kiowa Cultural Exchange Exhibition Committee” ; and,

(b) The “Kiowa Cultural Exchange Exhibition Committee” shall be comprised of five (5) members designated as “Committeeman”, who serve 2-year staggered terms of office, with each committeeman selected upon nomination by the Chairman and subject to confirmation by the Legislature; and,

(c) Coordinator shall be selected by the Committee to plan, coordinate, and report the group’s activities to the Chairman and/or his designee; and,

(d) The Executive Branch will fund 50% of the cost in an Annual Budget or Modification, voted and approved by the eligible voters of the Kiowa Tribe. The Kiowa Cultural Exchange Exhibition Committee will seek additional funding as needed through fundraising, to cover and/or defray cost of travel; and,

(e) The Chairman shall at any time remove any selected confirmed committeeman or coordinator for just cause and nominate a new committeeman or coordinator, for confirmation of the Legislature.

(f) The Chairman shall set a meeting fee to be paid for meetings requested and approved by the Chairman in the amount of \$_____ per meeting.

(g) Meetings may be set as in person or video (zoom sessions).

(h) The Chairman shall dismantle at anytime the “Kiowa Cultural Exchange Exhibition Committee”.
