STANDING ORDER IMPLEMENTING BOND SCHEDULE

Pursuant to the authority granted by Kiowa Code Chapter 5 § 1.5.1 (f), and in accordance with Kiowa Code Chapter 5 § 2.5.1 et seq., the attached Bond Schedule shall be adopted by the Court for immediate implementation by all law enforcement and corrections officers charged with enforcement of violations of the Kiowa Code.

It is Ordered that the following bond schedule be effective immediately in the Tribal Court of the Kiowa Tribe. This schedule shall be used by law enforcement officers when they make an arrest without an arrest warrant.

1. When an arrest is made, the arresting officer or jail deputy shall set bond at the above amounts. Such bond amount shall remain in effect until the Defendant is brought before a judge.
2. If a person is charged with more than one offense, the officer or jail deputy shall set bond at the level of the most serious offense.
3. A judge may reduce or increase the bond amount after an initial appearance in accordance with the Kiowa Code.
4. All bonds posted shall command the person arrested to appear for a hearing at a specific date and time.
5. If a person is arrested on a warrant, the bond amount in the warrant shall control.
6. Any person who does not post bond shall have an initial appearance within 48 hours of their arrest.
7. Offenses with named victims must comply with Title I, Chapter 5 §1.5.8 Victim's Rights.
