



## Kiowa Tribal Trial Court SMS Terms and Conditions

These Terms and Conditions ("Terms") govern the use of SMS messaging services provided by **Kiowa Tribal Trial Court** ("we," "us," or "our"). By opting into our SMS program, you agree to receive SMS messages from **Kiowa Tribal Trial Court**, in accordance with these Terms and The Campaign Registry (TCR) compliance standards.

### Consent and Opt-In Requirements

- By opting in, you provide express consent to receive SMS messages from us regarding your account services.
- Opting into the SMS program is voluntary and separate from any other service we provide.
- To opt-in, text "**KIOWATTC**" to (405) 233-1091 or sign up via our website at <https://www.kiowatribe.org/judicial>
  - **Opt-In Message:** Thank you for opting into **Kiowa Tribal Trial Court** texting. Message frequency varies. Message & data rates may apply. Reply STOP to unsubscribe. Text HELP or call (405) 901-9237 for more info.

### Message Frequency and Types

- Message Frequency varies.
- Message Types: Messages may include service alerts and account notifications.
- Message and data rates may apply according to your mobile carrier's standard rates.

### Opt-Out Instructions

- You may opt out of the SMS program at any time by texting "STOP" to (405) 233-1091.
- Once you send the "STOP" request, you will receive one final confirmation message confirming that you have been unsubscribed. No further messages will be sent unless you opt back in.
