## **Buffalo Fence Request for Proposal (RFP)**

---

### **OVERVIEW**

The Kiowa Tribe Natural Resource Department is requesting written quotes or invoices from qualified vendors and contractors for the construction of approximately nine (9) miles of bison (buffalo) fencing at the Tribe's Rainy Mountain Property located in Kiowa County, Oklahoma.

This request is structured to obtain clear, itemized pricing and is divided into two required cost components:

1. **Fence Materials (Materials Only)**
2. **Labor Hours and Labor Compensation**

Submissions do not need to be formal proposals. Itemized quotes or invoices are acceptable and encouraged.

---

### **PROJECT DESCRIPTION**

The project consists of furnishing fencing materials and/or providing labor necessary to construct approximately nine (9) miles of bison-grade fencing designed to safely contain American bison and support the Tribe's long-term livestock management, land stewardship, and cultural restoration efforts.

---

### **SCOPE OF REQUEST**

#### **PART ONE – FENCE MATERIALS (MATERIALS-ONLY QUOTE)**

Vendors may submit a materials-only quote or invoice that includes pricing for nine (9) miles of bison fencing.

Materials should be appropriate for bison containment and may include, but are not limited to:

- Line posts (type, size, material, spacing assumptions)

- Brace posts and corner assemblies
- Wire (type, gauge, tensile strength)
- Gates (quantity and size)
- Staples, clips, fasteners, and hardware
- Any additional materials required for a complete fencing system

**Materials quotes must include:**

- Itemized list of materials
- Unit prices and quantities
- Total materials cost
- Manufacturer or product specifications (if available)

---

## **PART TWO – LABOR & INSTALLATION (LABOR-ONLY QUOTE)**

Contractors may submit a labor-only quote or invoice for installation of nine (9) miles of bison fencing.

Labor quotes must include:

- Estimated total labor hours
- Hourly rates by labor category (e.g., crew lead, equipment operator, general labor)
- Total labor cost
- Description of construction methods and equipment
- Estimated duration to complete the work

Labor pricing must be separate from materials pricing.

---

## **TERO REQUIREMENTS (MANDATORY)**

This project is subject to Kiowa Tribe Tribal Employment Rights Ordinance (TERO) requirements.

All vendors and contractors must:

- Comply with applicable TERO policies
- Include TERO fees in their quoted pricing
- Identify TERO fees as a separate line item within the quote or invoice

Failure to acknowledge and include TERO requirements may result in disqualification.

*Vendors may submit quotes for materials only, labor only, or both.*
