Constitution approved by tribal

membership on April 17, 2017, and approved by Secretary

of Interior; and

WHEREAS: Article V, section 3(b) of the Constitution grants the Kiowa Indian Council the power to

set policy for the Tribe, and shall have all

other powers and duties specifically provided by the

Constitution; and

**WHEREAS:** The current term for the KIC Coordinator must

follow the Constitution, and

WHEREAS: The Legislature has the responsibility to store and

compile all approved laws not the KIC Coordinator,

and

WHEREAS: The changing means of communication must include

widely used methods of publication requires the posting of Notice of Annual and Special Meetings

must include social media as well as those listed in the

policies and procedures, and

WHEREAS: There is a need for a parliamentarian to advise the

KIC on proper conduct of meetings, and

**WHEREAS:** The Resolutions Committee has been enlisted to

ensure proper wording and compliance with the Constitution and Policies and Procedures, which will require a revision to specify Resolutions Committee

volunteer requirements, time for meetings, means of

selection, compensation and training,

NOW, THEREFORE BE IT RESOLVED, that this resolution of the Kiowa Indian Council hereby revises the current KIC policies and procedures for the length of term of office as the Coordinator, communication for Annual and Special meetings, appointing a parliamentarian at the Annual and Special meetings, deleting the duty of compiling and storing laws, and setting requirements for the Resolutions Committee to include compensation and when meetings will be held,

BE IT FURTHER RESOLVED, that this resolution shall revise the policy of the Kiowa Indian Council until a resolution is approved to supersede this revision.

### 5. Introducing a Kiowa Indian Council Resolution

The KIC shall call for volunteers or nominate at least 7 (one from each district) persons to become a resolutions committee to review all resolutions submitted for voting by the KIC for proper wording, adherence to the constitution requirements, and within the powers of the KIC.

Volunteers or nominees shall submit applications to serve on the Resolutions Committee to the Coordinator at least 60 days prior to the meeting of the Annual Meeting of the Council to serve at the following Annual Council Meeting to review resolutions submitted.

Names shall be submitted to the KIC to be voted on and approved for each district representative.

Specific requirements include:

Proof as enrolled Kiowa

Registered voter

Pass background check with no convictions as a felon

Reside in the district which they represent

Maintain confidentiality of review of resolutions

Attend all meetings to review resolutions

Submit to training of the Kiowa Constitution

Submit to training of Policies and Procedures of the KIC
Responsibility and duties of the Review Committee are to review
resolutions for compliance to the Constitution and the KIC Policies and
Procedures to include proper wording and to make recommendations to
the author(s) of the resolution; will have no authority to disapprove
resolution or change it without the approval of the author(s).
Prior assistance with composing resolution will be offered by Coordinator

before resolution comes to the Resolutions Committee.

Meetings will be held on an as needed basis. Time and place will be determined by the members of the Resolutions Committee and the KIC Coordinator.

Compensation for the committee members will be based on CONUS rates and time spent reviewing resolutions. District 7 representative will be given Conus rate mileage allowance and compensation for time spent reviewing resolutions.
