THE REVENUE ALLOCATION PLAN (RAP) FOR THE PEOPLE ACT OF 2025

WHEREAS, the Kiowa Tribe is a sovereign nation and has been so since time immemorial; and,

WHEREAS, the Tribe exercises full enjoyment of the inherent powers of government, including self-determination and autonomy over internal affairs encompassing Tribe citizens, lands, and resources; and,

WHEREAS, on April 17, 2017, qualified voters of the Tribe ratified the Kiowa Constitution as "the supreme law of the land"; and,

WHEREAS, the Kiowa Legislature is vested with the authority to pass laws and resolutions pursuant to Article VI, Section 6(a) of same Constitution; and,

WHEREAS, Article VI, Section 1 of the Kiowa Constitution further identifies a foundational duty of the Legislature to be "assessing the needs of the People"; and,

WHEREAS, the constituencies of the Legislature have both formally and informally voiced expansive support for the creation of a Revenue Allocation Plan (RAP) as well as the development of infrastructure for per capita payments to Tribe citizens; and,

WHEREAS, Article VI, Section 6(g) empowers the Legislature "to authorize per capita payments to Members of the Tribe by law"; and,

WHEREAS, on March 9, 2019, the Legislature unanimously passed the "Revenue Allocation Plan (RAP) Development Act," progress on which thereafter stalled; and,

WHEREAS, on June 21, 2025, at the Special KIC Meeting, Members of the Kiowa Indian Council voted by a margin of 132-21-30 to approve Resolution KIC-0010-2025, which mandates the "creation of a RAP" in calendar year 2025; and,

WHEREAS, a Revenue Allocation Plan is a critical component of bolstering financial transparency and accountability within the Tribe government as well as Tribe business enterprises; and,

WHEREAS, financial transparency and accountability are, in turn, key measures in protecting Tribe assets from abuse by external and internal actors alike; and,

WHEREAS, an equitable application of Tribe financial resources to the Cauigu people is a moral imperative for the Kiowa government;

Section 1.1 Short Title

This enactment shall be cited as the "Revenue Allocation Plan (RAP) For the People Act of 2025."

Section 1.2 Purpose

These provisions are enacted to define and establish in Tribe law the structure of a Tribe Revenue Allocation Plan as well as to delineate guidance and requirements governing the allocation of gaming revenue.
