LEGISLATIVE ORDER KL-CY-2026-

RESOLUTION IN AND FOR THE KIOWA TRIBE AUTHORIZING THE ADOPTION AND IMPLEMENTATION OF THE KIOWA TRIBE, INDIAN CHILD WELFARE, AND THE DEPARTMENT OF JUSTICE, TRIBAL ACCESS PROGRAM:

At a duly called Legislative Regular Session () of the Legislature of the Kiowa Tribe held this ___ day of ___, 2026, the following Order, was adopted.

WHEREAS the Kiowa Tribe is a federally recognized Indian Tribe exercising sovereign powers of self-governance; and

WHEREAS the Kiowa ~~Legislature Council~~ is the governing body of the Kiowa Tribe authorized to protect and promote the health, safety, and welfare of its members; and

WHEREAS the ~~Kiowa Legislature Tribal Council~~ recognizes the need to implement comprehensive and culturally responsive strategies to the Kiowa Tribe, Indian Child Welfare, Human and Health Services, Anadarko, Oklahoma. The Kiowa Tribe, Indian Child Welfare must have a method to submit required follow-up fingerprints as required by the Native American Children’s Safety Act of 2016, Public Law 114-165, within 15 working days to the Department of Justice, Tribal Access Program, FBI-approved Channeler, directly to FBI Criminal Justice Information Services; and

WHEREAS, the Kiowa Indian Child Welfare Program, Kiowa Health and Human Services has applied to a comprehensive Tribal Access Program (TAP) outlining clear goals, objectives, and community needs;

NOW, THEREFORE, BE RESOLVED, that the ~~Kiowa Legislature Tribal Council for the Kiowa Indian Child Welfare~~ hereby formally adopts and approves the Kiowa Tribe Indian Child Welfare Program, Department of Justice, Tribal Access Program.

BE IT FURTHER RESOLVED that the ~~Kiowa Legislature Tribal Council~~ authorizes the Kiowa Tribe Chairman David Sullivan, or his designee, to sign, submit, and execute all necessary documents, including a Memorandum of Agreement with the FBI Criminal Justice Information Services and reporting requirements related to the Tribal Access Program.
