KIOWA TRIBE ANNUAL AND/OR MODIFICATION BUDGET APPROPRIATION

At a duly called session of the Legislature of the Kiowa Tribe held this _____ day of ____, 202__, the following resolution and law were adopted:

WHEREAS, The Legislature is vested with the authority to pass an annual budget and budget modification for the Tribe pursuant to the Legislative process, and subject to approval by the voters, and

WHEREAS, The Legislature shall have the power to consider any budget proposals presented to the Legislature by the Chairman. The Legislature shall have the power to accept the budget proposal presented by the Chairman or develop its own budget proposals, and

WHEREAS, The Legislature shall have the power to pass an annual budget and budget modifications pursuant to the Legislative process.

NOW THEREFORE BE IT RESOLVED: The Legislature hereby enacts the attached “*Kiowa Tribe Annual and/or Modification Budget Appropriation*”, subject to final approval by the voters.

Section 1.1 Short Title

This enactment shall be known as the “Kiowa Tribe Annual and/or Modification Budget Appropriation”.

Section 1.2 Purpose

The purpose of the Act is to approve a “Kiowa Tribe Annual and/or Modification Budget Appropriation”, for the Tribe, subject to final approval by the voters.

Section 1.3 Findings

The Legislature hereby finds and declares that:

- (a) The Legislature is vested with the authority to pass an Annual Budget, and budget modifications, for the Tribe, subject to approval by the voters.
- (b) The Kiowa Constitution, which requires an annual budget and any budget modifications, to be approved by the Legislature and Chairman, with final approval by the voters.
- (c) The Legislature has identified the need to enact the “Kiowa Tribe Annual and/or Modification Appropriation” to include unidentified revenue and expenditures, including newly received funds and to address additional funding needs.
- (d) The Tribe shall operate on a fiscal year beginning July 1st and ending June 30th, Article 6, Section 6 (v) The Legislature shall have the power to raise revenue and appropriate funds for expenditure. Every funding item in an annual budget must have been previously authorized by law. No monies shall be drawn from the Treasury except by signature of the Chairman and except upon authorization and appropriation by law, (vi) if the Legislature fails to approve an annual budget within sixty days of presentment of a proposed annual budget by the Chairman to the Legislature by February 1st, then the annual budget presented by the Chairman shall be deemed approved for the purpose of placing such budget before the voters for approval or disapproval. If a new annual budget is not approved by the beginning of the fiscal year, then the most recently approved budget shall remain in effect until a new budget is approved.

Section 1.4 Approval of the Kiowa Tribe Annual and/or Modification Budget Appropriation.

The Legislature hereby approves the “Kiowa Tribe Annual and Modification Budget Appropriation”, subject to final approval by the voters as listed below.

Section 1.5 Final Approval by the Voters

Within thirty-days of approval of this budget by the Legislature and Chairman pursuant to the Legislative Process in Article VI, Section 8 of the Constitution, The Election Commission shall call and conduct an election for the voters to decide whether to approve the Kiowa Tribe Annual and/or Modification Appropriation.
