LEGISLATIVE ORDER KL-CY-2025-009

SUBJECT: To call a Special Meeting of the Kiowa Indian Council.

WHEREAS, the Kiowa Tribe is a federally recognized Indian Tribe and operates pursuant to the “New Constitution” approved by the voters of the Tribe in the Secretarial Election held on April 17, 2017; and,

WHEREAS, Article V., Section 4(b) of the Kiowa Constitution provides that Special Meetings of the Council may be called upon the request of six Legislators or via petition signed by four-hundred members of the Tribe who are eighteen years of age and older; and,

WHEREAS, the Constitution requires the Legislature to set the purpose of the Special Meeting when it mandates, “the purpose of the Special Meeting shall be indicated in the request for the Special Meeting and no other business shall be conducted at the Special Meeting”; and,

WHEREAS, the Constitution requires proposed resolutions to be submitted to the KIC Coordinator at least forty-five (45) days before the Special Meeting; and,

WHEREAS, the Constitution requires the KIC Coordinator to publish proposed resolutions at least thirty (30) days before the Special Meeting; and,

WHEREAS, members of the Tribe may submit proposed resolutions to the KIC Coordinator for a 2025 Special Kiowa Indian Council Meeting; and,

WHEREAS, members of the Tribe may now re-submit resolutions originally submitted in 2024 and 2025 as new proposed resolutions; and,

NOW THEREFORE BE IT RESOLVED, that pursuant to Article V., Section 4 (b) of the Constitution, the Legislature hereby calls a 2025 Special Meeting of the Kiowa Indian Council for the purpose of considering both re-submitted resolutions originally proposed in 2024 and 2025 as well as new resolutions, to be submitted to KIC Coordinator Joseph Granado.

CERTIFICATION

The foregoing Legislative Order KLO-CY-2025-009 was duly voted upon by the Legislature on April 25, 2025, at a Legislative Order Session V-(5) with a vote of (7) in favor and (0) opposed, (0) abstaining, and (0) absent, pursuant to the authority vested in the Legislature by the Constitution of the Kiowa Tribe.
