## KIOWA TRIBE RESOLUTION NO. KL-CY-2024-0XX

### KIOWA GAMING COMMISSION ORDINANCE ACT OF 2024

At a duly called Session of the Legislature of the Kiowa Tribe held this \_\_\_\_ day of \_\_\_\_\_ 2024, the following Resolution and Law were adopted.

**WHEREAS;** the Legislature is vested with the authority to pass laws and resolutions pursuant to Article VI, Section 6(a) of the Constitution of the Kiowa Tribe; and,

**WHEREAS;** the Legislature has enacted and approved an Ordinance to establish and govern the Kiowa Gaming Commission (“KGC”) to enact this law to govern and regulate the operation of class II and class III gaming operations in the Territory of the Kiowa Tribe; and,

**WHEREAS;** the Legislature has determined that it is in the best interests of the Tribe to set high standards of ethics and conduct for the Members of the Kiowa Gaming Commissioners, in order to demonstrate the Tribe’s commitment to regulate its casinos with the highest degree of integrity and professionalism; and,

**WHEREAS;** the Kiowa Tribe Legislature believes that it would be in the best interest of the Tribe, to enact the “Kiowa Gaming Ordinance Act of 2024”, to govern all gaming in Kiowa Tribal Territory and at all gaming facilities situated thereon.

**NOW THEREFORE IT BE IT RESOLVED;** that the Legislature hereby enacts the attached law entitled, “Kiowa Gaming Commission Ordinance of 2024”.

### **Section 1.1 Short Title**

This enactment shall be known as the “Kiowa Gaming Commission Act of 2024”.

### **Section 1.2 Purpose**

The Legislature of the Kiowa Tribe (herein the “Tribe”), empowered by the will of the Kiowa People as expressed and limited in the Kiowa Constitution, hereby enacts this law in order to govern and regulate the operations of class II and class III gaming operations in the Territory of the Kiowa Tribe.

### **Section 1.3 Findings**

The Legislature hereby finds and declares that:

- (a) All gaming, including without limitation, Class II and Class III gaming is, subject to licensure by the Kiowa Gaming Commission and compliance with the requirements of Kiowa law, to be conducted in Kiowa Territory.
- (b) Gaming is conducted in accordance with this law, Indian Gaming Regulatory Act, NIGC regulations, and any other applicable laws or regulations duly promulgated by the Kiowa Gaming Commission, pursuant to this law.

### **Section 1.4 Authorization**

- (a) The Legislature hereby enacted and approved a Kiowa Gaming Commission Act of 2024, to regulate the Kiowa Tribe’s gaming business.
