### **Request for Proposal (RFP) for Orphan Well Plugging and Remediation**

#### **Introduction:**

The Kiowa Tribe orphan oil and gas well remediation program invites proposals from qualified contractors for the plugging and remediation of orphan wells within affected Kiowa tribal land jurisdiction. Orphan wells pose significant environmental and safety hazards, and it is imperative to address them promptly and efficiently.

#### **Objective:**

The primary objective of this RFP is to solicit proposals from experienced contractors to effectively plug and remediate orphan wells in accordance with applicable regulations and industry best practices. The selected contractor will be responsible for conducting all necessary activities to ensure the safe and environmentally sound abandonment of orphan wells.
