## LEGISLATIVE ORDER KL-CY-2023-0XX

### ENACTMENT OF RESOLUTION 0040 KICCY-2018 BUDGET BY LINE ITEM

At a duly called Session of the Legislature of the Kiowa Tribe held this \_\_\_ day of \_\_\_\_\_ 2023, the following Resolution was adopted.

**WHEREAS;** the Legislature of the Kiowa Tribe is vested with the authority to pass laws and resolutions according to Article VI, Section 6(a) of the Constitution of the Kiowa Tribe; and,

**WHEREAS;** the purpose of this resolution is to enact KICCY2018 Resolution 0040 which requires the annual budget for the Kiowa Tribe to be presented, discussed/described, and voted upon by a “item line vote” procedure in the spirit of transparency and a high standard of accountability; and

**WHEREAS;** the Kiowa Tribe will adopt a budget beginning annually in July and ending in June. This budget, as voted on and adopted by item line vote by the KIC, will be organized in a budget narrative formatted document, line item by line item, to be presented, processed, and distributed accordingly by the Executive Branch; and,

**WHEREAS;** approval of a line item budget will require specific approval for each line item as presented, from the KIC on budget expenditures, granting clear transparency to all involved, on how all monies are to be expended for that year.

**NOW THEREFORE, LET IT BE RESOLVED;** the Legislature, as a result of this, enacts the attached resolution entitled, “Budget Transparency Law – Establishing Line Item Budget Vote.”
